An Update on early flight in Altona







The Herald - Tuesday 28th February 1911



The Society has recently had several visits from Melbourne resident and Journalist, Kate Baillieu who is researching some early history in regard to family members,in particular her Grandfather Bill Knox,and M.H (Jac) Baillieu,the latter being acknowledged as the first

commercial paying passenger taken aloft in a flight from Altona, and the former also a passenger on in a later flight on the same day undertaken with New Zealand pilot J. J. Hammond, employed by the British and Colonial Aeroplane Co. (Bristol).

Of particular historical relevance is the handwritten letter retained by Ms Baillieu from Mr. Knox to his sweetheart "Mim", written on the

evening of the flight 2nd March 1911, indicating how he had enjoyed it.

Also of interest is a copy of a newspaper article from the Herald dated 28 Th. February 1911 in which an interview with Mrs. J J Hammond was published in a section known as "Women's World".

Mrs. Hammond indicated that she had made a number of flights with her husband the first being in Stonehenge, Wiltshire and that the "novelty of flying has worn off a bit".

When interviewed in WA, J. J. Hammond was though to be "telling a terrible fib" when he said his wife often went up with him "but now they know it was true".

Fashions of the Day - The Aerial Costume

From the same article - To Mrs. Hammond Question - "Do you wear any special costume for the flight."

"No I could go up just as I am now,but it would be rather cold. " (She was wearing a summer frock of tussore silk and a small bonnet shaped hat).

"I would not have any ribbons or veils flying or a flowing skirt that would catch in the wind, but this idea of wearing knicker costume is only affectation aping the man.

It is a fad and not a necessity, I general wear an ordinary skirt, not a full one and a guernsey or a jacket, it is very cold in the air.

Then I wear a woollen cap'.

The significance of early Aviation from a Military aspect.

In the early years of Aviation it was realised by Governments and Military advisors around the World that the ability to overfly territory had a potential benefit for military use.

The web site of the Australian National Aviation Museum contains much information in regard to Aviation that is of interest to those seeking information regarding past and present history on all aspects of Aviation.

They advise that from around 1906, military interest arose in "Flying Machines" which offered mobility and range in order to observe troop and gun movements.

In 1909 the Aerial League of Australia was formed in Sydney and Branches followed in Victoria and Queensland.

They lobbied the Government for a "competition" for military aircraft, and its aim was to get the Government to establish an aviation school, and aviation corps under the Defence Department.


In 1909 Frenchman Louis Bleriot had flown across the English Channel, making Britons realise that they were open to attack, other than by sea.

Australia

In Australia in September 1909, Senator (Sir) George Pearce, Minister for Defence approved requirements for a competition for the best and most suitable aeroplane for Military

purposes with a prize of 500 pounds offered. In 1910 two manufacturers despatched aircraft crews to Australia, for demonstration purposes. It was from this early beginnings that planes from the Bleriot and Bristol companies were attracted to Australia ,and this eventually led to the establishment of the facility at Point Cook in 1912 and subsequently the Australian Flying Corps, and air force that is now the Royal Australian Air Force.

Altona Fire Station is 50 years old

The Altona Fire Station, which is the Metropolitan Fire Service Station Number 46 located at 7 Akuna Street Altona is about to turn 50 years old since the original building was constructed.

The Station Officer has approached the Altona Laverton Historical Society seeking any photos or information that may be available to give them information regarding the opening or the early history of the Altona Fire Station.

At this time we do not seem to have any particular information that would assist them and we request any members who may have images or information regarding the early history of the site to contact the Society so that we may pass information along if available.

It is advised that shortly construction will begin on a new building at the site, and this in itself will be worthy of recording for future historical reference.

As well as attending to Fires and similar emergencies, Fire Service members now also respond to medical emergencies, so it is possible if you dial Triple Zero in an emergency, it may not be an Ambulance which arrives, but a fully manned Fire Tender with crew.

The Fire Service - History from the Past

The development of Metropolitan Fire Service in Australia followed in the main the procedures that were adopted in the United Kingdom.

The original Fire Services began to develop from private brigades employed by the Insurance Companies established in the Seventeenth and Eighteenth Centuries, before the establishment of public brigades the insurers established their own, in the interest of self preservation of their insured assets.

For example the Royal Exchange Assurance Company established by Royal Charter in 1720 had by 1721 several (hand propelled) engines and 56 firemen, with 21 porters to remove goods.

Parishes were under a legal obligation to provide brigades but this fell away as insurance brigades were established.

The book "Royal Exchange Assurance 1720-1970" states that "the attraction to serve in the brigades was considerable, and included not merely generous pay (normally in the eighteenth century, a shilling for the first and sixpence for each succeeding hour) and the attractive uniform, but also the immunity from the naval press-gang. There were long waiting lists for vacancies".




Fire Marks









Metal plaques bearing the symbols of fire insurance offices in the United Kingdom and known as "Fire Marks" were introduced in the 17 Th. century when the first insurance fire offices commenced business.

Their use continued in the United Kingdom up to the middle of the 19 Th. Century when their original purpose of identifying the insured property gradually disappeared.

It was originally the custom of the insurers to issue with each policy a "mark" which was nailed to a prominent part of the building.

It also became customary for the fire offices to pay rewards to bystanders who gave a prompt warning of fire in an insured building or who assisted the offices fire men in manning the fire pumps, and it was usual for the offices to pay for beer supplied to the firemen and their "assistants" during the thirsty work of fighting a fire, a prominently displayed Mark indicated that the building was insured and rewards for assistance were likely. (an early version of Crime stoppers).

The earliest known mark issued was that of Nicholas Barbon's Fire Office of 1680, sometimes called the Phoenix because of the figure of a phoenix on the mark, the company went out of business in 1711 and no known marks survive.

Fire Marks are now an antique and collectors items of interest to those in the Insurance profession.

Reproduction Marks of various companies are on display at the Melbourne Fire Museum at Eastern Hill and are available for purchase.

CHERRY LAKE AS A RACING CAR VENUE

President Peter Weaver has recently received a very interesting article from a publication called



"Closed Circuit" from Jim Testa who had a relative who died during an early motor car racing event on what was a racing circuit around "Cherry Lake".

The opening race meting was held on March 8th 1954, opportunities were few to hold motor race meetings around Melbourne and a new purpose built track was established at what is now Cherry Lake.

The Circuit was established on a flat parcel of land at a time in which the area was in part swamp land it is quoted that "it had a hard surface once the water evaporated".

A company was formed to build a circuit to race around the lake and work started on a 3.6 km circuit with a

projected road width of 7.5 metres.

The article states that some low lying areas were traversed with a rock land fill to build up to road level.

At the opening meeting on the 8th March 1954, entries included Stan Jones in a Cooper 1100, Jack Brabham in his Cooper Bristol and Doug Whiteford in a Lago.

However as time progressed very few people turned up to pay at the turnstile.

The track was considered dangerous and included boulders.

A fatality occurred.

Four meetings were held but other venues such as Phillip Island and Albert Park eventually took over.

So for a brief period in time Altona played a part in motor racing history in Victoria.

Reply from Consumer Affairs Victoria

The minutes of the last general business

One of the matters raised at that meeting was a request by member Bob Hawkins to clarify the position of "Financial members" under the Model Rules of the Associations Incorporation Act.

As agreed at that meeting a written submission was made to the Department of Justice (Consumer Affairs Victoria) with the request of clarification of the intent and application of Rules 4.12 ("The Annual Subscription is payable in advance on or before the 1st July in each year") and Rule 16.4 (A member is not entitled to vote at a general meeting unless all monies due and payable by a member of the Association have been paid other than the amount of the annual subscription payable in respect of the current financial year").

Their written reply is

"Section 14A(1) of the Associations Incorporation Act 1981 (the Act) states that the rules of an incorporated association constitute the terms of the contract between the incorporated association and its members.

If verbal advice has been given by Consumer Affairs Victoria,it should not have been.

As the rules are a contract between the association Consumer Affairs can not give an interpretation of the rules,regardless of whether the rules being followed are the model rules or the incorporated associations own rules.

It is up to the incorporated association to determine what the rules mean to them.
